Standing Items:

*Treasurer's Report:* Fred presented the FMAC 2018 Budget compared to Actuals January-September. Bottom line is we are "doing pretty well." *Event Report:* "The Tempest" summer show earned net of \$2280, approximately half of which went to CCE. 319 attended.

"King's Cutlery" dinner theater was enjoyed by 35 guests plus 6 of King's Court and 9 staff. There were several out of town guests in costume. As the income and expenses were about the same, next dinner theater must have a strict budget.
